- 70% against RA
- 10% after approval of TATA warranty.
- LD applicable at 0.5% per week of contract value, maximum up to 5%.

3. **NOTE**:

- Work execution date shall be intimated at least 10 days in advance to allow for manpower planning. Work should be carried out as per planning done by Raj Group team.
- Project Completion 20 days from date of material receipt
- If any material is pending from Raj Group side, then sub- contractor shall intimate us before one week.
- Any damage or theft of material is in your scope and the same amount shall be compensated from final billing.
- All safety rules of Company and Raj Group should be followed. Safety equipment (Helmet, safety shoes, safety belt) will be compulsory. Failure to maintain proper safety rules may lead to strict action against sub-contractor.
- Lodging, Boarding & Local conveyance shall be in sub-contractor scope.
- Before leaving site, it is your responsibility to arrange all material at proper place.
- Testing work after installation of material includes alignment, megger test, and commissioning certificates. Any necessary support required from sub-contractor should be fulfilled.
- If any modification is required due to improper work technique, then required material should be purchased by vendor.
