1. The above rates are inclusive of total system cost and its installation, commissioning, transportation, insurance, five year AMC/CMC, and applicable fee and taxes (GST etc).
2. The contract shall be valid for a period of 12 months from the date of empanelment, which is to be extended on satisfactory performance and mutually agreed terms & conditions between UPCL and vendor, if required.
3. All other terms & Conditions shall be as per e-tender specification No. CCP-I/28/2019-2020.
4. **PERFORMANCE SECURITY / PERFORMANCE BANK GUARANTEE (PBG):**

At the time of signing the Contract, the Contractor shall submit the Performance Security (PBG) of Rs. 2.5 Lakh (Two Point Five Lakh) only. This PBG shall be considered equivalent to 100kWp capacity. During execution of the contract, whenever the quantum of work increases beyond 100kWp capacity, the contractor shall submit additional PBG of Rs 2.5 Lakh. Similarly, whenever the quantum of work increases beyond 200kWp capacity, the contractor shall again submit additional PBG of Rs. 2.5 Lakh and so on.

The above Performance Security (PBGs) shall be submitted in favor of Executive Engineer, Electricity Store Division, UPCL Dehradun in the form of DD/FDR/CDR/Bank Guarantee valid for a minimum period of 66 Months from the date of issue of allocation letter to the Firm and shall be extended till the completion of 5 years warranty period plus 03 months claim period. The PBG shall be released after successful compliance of entire obligations in the contract.
